All that piece, parcel or lot of land situate, lying and being in Piedmont, Greenville County, State of South Carolina, being Lot No. 22, Section 4, on plat by Dalton & Neves, February, 1950, recorded in the R.M.C. Office for Said County in Plat Book "Y", at pages 2 - 5; said Lot is located on Langston Street and fronts thereon for 88 feet. This conveyance is subject to the rights - of - way and easements heretofore granted by the Granting Predecessors in title, to certain Utility Companies, reference to previous deeds will more clearly show the extent of such, and to certain restrictions, the extent of which is numerated in said deeds.
