"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of Fairview Avenue, in the City of Greer, being known and designated as Lot No. 12, in Block 1 on a plat recorded in the R.
