## The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgages for such further sums as may be advanced hereafter, at the option of the Mortgages, for the payment of taxes, insutance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. - (4) That it will pay, when due, all taxes, public assessments, and other governmental or municipal charges, fines or impositions againt the mort-paged premises. That it will comply with all governmental and municipal laws and regulations affecting the mortgaged premises.
- (5) That it hereby assigns all rents, issues and profits of the mortgaged premises from and after any default hereunder, and agrees that, should legal proceedings be instituted pursuant to this instrument, any judge having jurisdiction may, at Chambers or otherwise appoint a receiver of the mortgaged premises, with full authority to take possession of the mortgaged premises and collect the rents, issues and profits, including a reasonable rental to be fixed by the Court in the event said premises are occupied by the mortgager and after deducting all charged and expenses stituting such proveding and the execution of its trust as receiver, shall apply the residue of the rents, issue and profits toward the payment of the delst secured hereby.
- (6) That if there is a default in any of the terms, conditions, or covenants of this mortgage, or of the note secured hereby, then, at the option of the Mortgage, all sums then owing by the Mortgage to the Mortgage shall become immediately due and payable, and this mortgage may be foreclosed. Should any legal proceedings be instituted for the foreclosured of this mortgage, or should the Mortgages due a party of my mill involving this mortgage or the title to the premises described herein, or should the delt secured hereby or any part thereof be placed in the hands of any attorney or cultertion by suit or otherwise, all coats and expenses incurred by the Mortgage, and a reasonable attorney's fee, shall thereupon become the and payable immediately or on demand, at the option of the Mortgage, as a part of the debt secured hereby and may be trovered and collected hereumder.
- (7) That the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mortgage or in the note accurred hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of the mortgage, and of the note accurred hereby, that then this mortgage shall be utterly noil and void; otherwise to remain in full force and virtue.
- (6) That the covenants kerein contained shall hind, and the benefits and advantages shall inure to the respective heirs, executors, administrators, successive and assigns, of the parties hereto. Whenever used, the singular shall include the pluris, the plural the singular, and the use of any gender shall be applicable to all genders.
