"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenvillo, boing shown and designated as Lot No. 40 on plat of Super Highway Home Sites, as recorded in Plat Book P, at page 53, and having, according to said plat, the following metes and bounds. to-wit:
