"ALL that certain place, parcel or Wekof land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being shown on a Plat of Property of Shannon Forest Presbyterian Church, made by C. O. Riddle, Engineer, January 15, 1970, and having, according to said plat the following metes and bounds. to-wit:

BEGINNING at an iron pin on the westerly side of a County Road at joint corner of Property of Albert E.
