All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northern side of Pettigru Street in the City of Greenville, Greenville County, South Carolina, being shown and designated as the Eastern portion of Lot No. 8 on a Plat of Boyce's Addition dated January 13, 1904, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book A, Pages 90 and 91, and being shown on a Plat entitled "Property of Christ Church" made by Dalton and Neves, Engineers, dated June 22, 1960, recorded in the R. M. C. Office for said county and state in Plat Book UU, Page 35, and having according to said Plats the following metes and bounds, to wit:
