Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Range View Circle at the joint front corner of lot 18 and lot 19 and running thence with Range View Circle N. 69-07 E. 75 feet to an iron pin; thence with the curvature of the southern corner of the intersection of Range View Circle and Stacey Drive, the chord being S. 66-19 E. 35.7 feet to an iron pin on the western side of Stacey Drive; thence with the said Drive, S. 21-46 E. 125.1 feet to an iron pin at the corner of lot 10 and lot 19; thence with lot 10 S. 69-07 W. 102.5 feet to an iron pin at the joint rear corner of lot 18 and 19; thence with lot 18 N. 20-53 W. 150 feet to point of beginning.
