TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as herein specifically stated otherwise as follows:

The Mortgagor further covenants and agrees as follows:

- (1) That this mortragic shall secure the Mortrague for such further sums as may be advanced hereafter, at the option of the Mortrague, for the nowment of taxes, insurance premiums public assessments, repairs or other purposes pursuant to the covenants herein. This mortrague shall also secure the Mortragues for any further loans, advances, readvances or credits that may be made hereafter to the Mortragues by the Mortragues so long as the total indebtedness thus secured does not exceed the original annish shown on the face hereof.
