11. That in the event this mortgage should be foreclosed, the Mortgagor expressly walves the benefits of Sections 45-88 through 45-90.1 of the 1962 Code of Laws of South Carolina, as amended, or any other appraisement laws.

The Morigagee covenants and agrees as follows:

- 1. That should the Mortgagor prepay a portion of the indebtedness secured by this mortgage and subsequently fall to make a payment or payments as required by the aforesaid promissory note, any such prepayment may be applied toward the missed payment or payments, insofar as possible, in order that the principal debt will not be held contractually delinquent.

Should any legal proceedings be instituted for the forcectours of this mortgage, or should the Mortgage become a party to any suit involving his Mortgage or the fillet of the premises described herein, or should the debt secured hereby or any part thereof be placed in the hands of an attorney at law for collection by suit or theretwe, all costs and expenses incurred by the Mortgage, and a reasonable actioner's fee, shall thereupon become due and payable immediately or on demand, at the option of the Mortgage, as a part of the debt secured thereby, and may be recovered and collected hereunder.

It is further agreed that the covenants herein contained shall bind, and the benefits and advantages shall inure to, the respective heirs, executors, administrators, successors, and assigns of the parties hereto. Wherever used, the singular shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
