NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereot, and of any other and further sums for which the Mortgagor may be incideded to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe and also in concluderation of the further sum of Three Dollars (\$3.00) to the Mortgagos in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, barguined, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, about two miles southwestward from the City of Green, on the West side of State Highway No. 14,

Moss 0. and Zobedia Black, plat thereof recorded in Plat Book FF, page 18, R.M.C. Office for Greenville County, and having a frontage of 99.6 feet on State Highway No. 14, with a depth of 157.8 feet on the north side, a rear line of 95.8 feet, and a depth of 132 feet on the south side.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
