All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southeasterly intersection of Botany Road and Imperial Drive, being shown and designated as Lot No. 288, on plat of Botany Woods, Sector VI, recorded in the RMC Office for Greenville County, S. C., in Plat Book "YY", at Page 131, and having, according to said plat, the following metes and bounds, to wit:
