The mortgagors also will furnish to the mortgagee, without expense to the mortgagee, certified statements of the mortgagor's income and expenses with respect to the mortgaged property within three (3) months after the end of each fiscal year. The statement shall contain the total gross sales of tenants on percentage leases, if any.

to exercise any option to declare the maturity of the debt secured hereby under the foregoing conditions shall be taken or deemed as a waiver of right to exercise such option or declare such forfeiture, either as to any past or present default on the part of the mortgagors, nor shall any default as to the procurement of the insurance or payment of the taxes by the mortgagee as hereinabove provided be taken or deemed as a waiver of the right to declare the maturity of the indebtedness hereby secured by reason of the failure of the mortgagors to procure such insurance or pay such taxes.
