"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Henderson Road in the City of Greenville, being shown as Lot 74 on plat of Section F of Gower Estates recorded in Plat Book JJJ at page 99 in the RMC Office for Greenville County, and having according to said plat the following metes and bounds:
