with interest thereon from date at the rate of eight (8) per centum per annum, to be paid: Annually

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

- "ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as

a 3.03 acre tract more or less as shown on a plat of the property of R. V. Chandler & Co., Inc., dated February 25, 1970, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a nail in the center of Garrison Road near the southern corner of the intersection of Garrison Road and Richey Road and running thence N. 64-50 W. 530 feet to an iron pin; thence N. 20-10 E. 250 feet to an iron pin; thence S. 64-50 E. 530 feet to a nail in Garrison Road; thence along Garrison Road S. 20-10 W. 250 feet to a nail which is the point of beginning.
