> ALL that certain piece, parcel, or lot of land in the City of Greenville, Greenville County, State of South Carolina being located on the eastern side of Lavinia Avenue and known and designated as Lot No. 25 according to a plat of Property of Rowley Place made by W. A. Adams, Engineer, and recorded in the R.M.C. Office for Greenville County in Plat Book C, Page 5, and being more particularly described according to a plat made by Pickell & Pickell, engineers, October 4, 1944, as follows:

Beginning at a stake on the eastern side of Lavinia Avenue at the joint front corner of Lots No. 25 and 26 and running thence with the line of said lots.
