Bayne, prepared April 3, 1965 by H. C. Clarkson, Jr., and having according to said plat the following courses and distances, to-wit:

BEGINNING at an iron pin on the northeastern side of Scuffletown Road, and running thence N. 61-00 E., 219.8 feet to an iron pin; thence N. 13-15 W. 185 feet to an iron pin; thence S. 60-00 W. 325 feet to an iron pin; thence along the right-of-way line of the Scuffletown Road S. 47-00 E. 185 feet to the point of beginning.
