"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, about two miles west of Brushy Creek Baptist Church on Hudson Road, having the following metes and bounds:

Beginning at a nail and cap in the center line of Hudson Road, corner of James Barton; thence with his line, S 17-30 E 21.7 feet to an iron pin; thence with same course 612 feet to an iron pin across branch to the south side; thence down south side of branch, S 60-55 E 134 feet to an iron pin; thence N 17-40 W 713 feet to nail and cap in the center line of said road; thence with said road, S 70-50 W 90 feet to the beginning;
