All that certain piece, parcel, or lot of land, with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side, of Melody Drive, in Sharon Park Subdivision, which is known and designated as Lot 68 of that Subdivision, and which is described more particularly as follows according to a plat of that Subdivision recorded in the Office of the R. M. C. for Greenville County in Plat Book CCC, Page 71.
