All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the western side of Overton Court near the City of Greenville, in the County of Greenville, State of South Carolina, and known and designated as Lot No. 83 of a subdivision known as Cedar Vale, Section 2, plat of which is recorded in the R.M.C.
