"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, near and east of the city of Greenville, and being known and designated as Lot Number 6 of a subdivision known as Terra Pines Estates, Section 4, on plat of which is of record in the RMC Office for Greenville County in Plat Book 000 at page 85, and having the following metes and bounds, to-wit:

Beginning at a point on the southeastern side of Compton Drive at the joint front corner of Lots 6 and 7, and running thence with the southeastern side of Compton Drive S. 19-30 W. 193 feet to a point; thence following the curvature of the northeastern intersection of Compton Drive and a proposed street (the chord of which is S. 25-30 E.) 35.3 feet to a point; thence with the northeastern side of said proposed street S. 70-30 E. 175 feet to a point at the rear corner of Lot 6; thence N. 19-30 E. 218 feet to a point at the joint rear corner of Lots 6 and 7; thence N. 70-30 W. 200 feet to a point on the southeastern side of Compton Drive at the point of beginning.
