NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3,00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville in Bates township on the Northern side of Whitehouse rd, a short distance west of Greenville-Hendersonville highway and having the following metes and bounds

Beginning at an iron pin, corner of H.G. Duck and Henry Williams, thence S. 76 E 5.80 chains to center line of Whitehorse road, there with said road S. 32½ E. 1.60 chains to a point in White Horse Road; thence with said road, N. 59 3/4 W.5.52 chains to the beginning corner. Containing .45 of an acre, more or less, according to a survey made by J. Earle Freeman 10-10-44. Being the same property conveyed to the Henry Williams by H.G. Duck by deed recorded in Vo. 250 at page 232.

Also all that other tract of land in Bates township, about 6 miles North of Travelers Rest, on White hoorse road, and having th following metes and bounds according to survey by W.A. Hester dated 11-15-39.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
