"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, located on the East side of Miller Drive and being shown and described as Lot Number Thirty (30) on a plat of property entitled "Fleming Heights" made by Robert Jorden, surveyor, dated September 27, 1957, and recorded in Plat Book KK, Page 113, Greenville County R.M.C. Office and having the following metes and bounds according to said plat.

BEGINNING at an iron pin on the East side of Miller Drive at the joint front corner of Lots 30 and 29 and runs thence N. 69-08 E., 201.4 feet along the lines of Lots 29 and 27 to a point on the line of Lot 26; thence S. 0-35 W., 97.6 feet along the line of Lot 26; thence S. 65-25 W., 166 feet to an iron pin on the East side of said drive; thence N. 20-52 W., 100 feet along the East side of said Miller Drive to the beginning corner.
