NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

BEGINNING at an iron pin on the Eastern side of Allen Street, joint front corner of lots 58 and 59, which iron pin is 74.2 feet South of a 15 foot alley, and running thence with the joint line of said lots, S. 53-13 E. 124.5 feet to an iron pin on the Western side of a 15 foot alley; thence with the curve of said alley, S. 12-48 W. 55 feet to an iron pin, joint rear corner of lots 57 and 58; thence with joint line of said lots, N. 53-13 W. 146.9 feet to an iron pin on the eastern side of Alley Street; thence with said Street, N. 36-47 E. 50 feet to the beginning corner.
