"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Fairview Township, located on the South side of proposed extension of Cox Street, and East of South Street in the Town of Simpsonville, adjoining lands of W. P. Jones, L. L. Richardson, Frank R. Coyle, and other lands of Grantor, and having according to a survey and plat made by E. E. Gary, Surveyor, on June 7, 1948, the following metes and bounds:

BEGINNING at an iron pin on South Side of Cox Street Extension and joint corner with other lands of G. B.
