Tract One: ALL that piece, parcel or tract of land, together with buildings and improvements, situate, lying and being on the Northern side of U. S. Highway No. 1-85, on the Southern side of the Augusta Road to Batesville (Brushy Creek Road) and on the Eastern side of an unnamed County Road, in Butler Township, Greenville County, South Carolina, being shown as Tract No. 1, containing 17.27 acres, on a Plat of the Property of N.
