"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of White Horse Road and being a portion of the property shown on plat of Westwood Plaza dated October, 1967, and recorded in the RMC Office for Greenville County in Plat Book "VVV" at page 111 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin in the rear line of said property (rear being the western side thereof) at the corner of property heretofore deeded to Perry S. Luthi, as Trustee, et al; which iron pin is located 238.6 feet from Broadway Drive; and running thence along the rear line of said Westwood Plaza property, S. 19-29 W. 60.88 feet; thence S. 80-15 E. 153.7 feet to a point on the east side of the 25-foot drive; thence N. 69-15 E. 181.7 feet to a point on the southwest side of White Horse Road; thence along said Road, N. 22-05 W. 51.7 feet to an iron pin in the line of property heretofore deeded to Luthi, et al; thence along the line of said Luthi Property, S. 69-15 W. 150 feet to an iron pin and N. 80-15 W. 143.4 feet to the point of beginning.
