Beginning at an iron pin on the southwestern side of Twinbrook Drive at the joint front corner of Lots 67 and 68; thence S 56-37 W 185 feet to iron pin; thence N 32-07 W 100 feet to iron pin; thence N 56-37 E 189.9 feet to pin on Twinbrook Drive; thence along the southwestern side of Twinbrook Drive, S 30-26 E 100 feet to the beginning corner.
