"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, state of S.C. lying on West Side Taylors, to Brush Creek road, and bounded by lands of Chas, Hammett and other land of Grantor and having the following Metes and Bounds.

Beginnin at the SE corner of Grantors land marked by Nail and Cap in the County Road and running thence along Road N. INDEN 10-00W. 100 feet to nail and cap; thence S 76-13 W. 151.7 feet to iron pin; thence S 4-15 W. 50 feet to iron pin on Hammett line; thence 585-45 E. 169.0 feet to beginning and contains 0.28 acres more or less.
