All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the west side of Capers Street in the City of Greenville, County of Greenville, State of South Carolina and being known and designated as a portion of Lot No. 1 as shown on a plat of property of Alester G.
