NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville on the northern side of Old Mill Road and known and designated as Lot No. 47 of a subdivision known as Edwards Forest Heights, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book 000 at Page 89 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 46 and 47 and running thence with the joint line of said lots N. 48-58 E., 165.8 feet to an iron pin at the joint rear corner of said lots; thence S. 35-22 W., 130.7 feet to an iron pin at the joint rear corner of Lots Nos. 47 and 48; thence S. 54-38 W., 165 feet to the joint front corner of said lots on Old Mill Road; thence along Old Mill Road N. 35-22 W., 97 feet; thence continuing along Old Mill Road N. 37-26 W., 17 feet to an iron pin, point of beginning.
