NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

PALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin Township, on the East Georgia Road (S. C. Highway 417) near Simpsonville, S. C., containing one acre according to plat of Property of Paul A. and Lola K. Jordan prepared by C. O. Riddle, Reg. L. S., September, 1970, recorded in the R. M. C. Office for Greenville County in Plat Book 4H at page 35, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on East Georgia Road (S. C. Hy. 417) which pin is S. 61-10 W. 466.8 feet from iron pin at southeast corner of other property of the mortgagors on S. C. Hy. 417; and running thence with S. C.
