"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located on the southwesterly side of Scuffletown

Road, being shown as a 33.4 acre tract on a plat entitled Survey for W. H. Alford, prepared by Carolina Engineering and Surveying Company, dated August 19, 1970, and recorded in the R.M.C. Office for Greenville County in Plat Book UUU, Page 193, and having such metes and bounds as shown thereon. Reference to said plat being craved for a more complete and detailed description.
