All that certain piece or lot of land situated, lying and being in Glassy Mountain Township, Greenville County and State of South Carolina on waters of Jameson Mill Creek waters of South Pacolet River to wit: BEGINNING on a stone in Jameson Creek running near West 570 feet to a stone in field; thence near South 258 feet to stone Gosnell and Lockhart corner; thence with F. M. Gosnell line near South West 450 feet to iron pipe, Gosnell and Lockhart corner; thence near N. W. with said line 600 feet to stone on North bank of creek where branch runs into creek; thence down with said creek near East with meanders of creek to BEGINNING of corner containing by estimated (9) acres more or less or same.
