"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, near the Village of Travelers Rest, containing 77/100 acre, more or less, same being on the eastern side of Robinson Street in subdivision known as Roosevelt Heights, and, according to plat recorded in Plat Book 'W', page 129, in part, having the following metes and bounds, to-wit:
