

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on Old Mill Road, being shown as
