MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, Richard H. Ginther and Jeanne E. Ginther, of Greenville County,
(hereinafter referred to as Mortgagor) (SEND(S) GREETING
WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION C GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of
Twenty-Six Thousand, Eight Hundred Fifty and No/100 (* 26, 850, 00
Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note
conditions), said note to be repaid with interest as the rate or rates therein specified in installments of
Two Hundred Seven and 25/100
paid, to be due and payable25 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS; the Mortgagor may hereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 58 of a subdivision known as Merrifield Park according to a plat thereof prepared by C. O. Riddle, dated October 1967 and recorded in the R. M. C. Office for Greenville County in Plat Book 000 at Page 177 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Hillsborough Drive at the joint front corner of Lots 57 and 58 and running thence with the joint line of said lots, S. 19-00 W. 180 feet to an iron pin in the line of Lot 76; thence with the lines of Lots 76 and 75, N. 71-00 W. 110 feet to an iron pin at the joint rear corner of Lots 58 and 59; thence with the joint line of said lots, N. 19-00 E. 180 feet to an iron pin on the southern side of Hillsborough Drive, joint front corner of Lots 58 and 59; thence with the southern side of Hillsborough Drive, S. 71-00 E. 110 feet to the point of beginning;
