"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and having according to survey made by John C. Smith, Surveyor, October 12, 1966, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwest side of South Carolina Highway #20, said pin being 200.9 feet in a northeasterly direction from the point where the Northwest side of South Carolina Highway #20 intersects with the Northeast side of a county road and runs thence along the line of other property now or formed y owned by Jean D.
