That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Mauldin, being known and designated as Lot 52 as shown on plat of a subdivision known as Glendale 2 prepared by C. O. Riddle, December 1965 and recorded in the R.M.C. Office for Greenville County in Plat Book OOO at Page 55 and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southern side of Sycamore Drive, joint front corner of Lots 52 and 53 and running thence with the joint line of said lots, S. 13-04 E. 220.8 feet to an iron pin in the line of Lot 54; thence with the rear line of Lot 52, N. 49-46 E. 157 feet to an iron pin, joint rear corner of Lots 51 and 52; thence with the joint line of said lots, N. 30-20 W. 171.2 feet to an iron pin on the southern side of Sycamore Drive, joint front corner of Lots 51 and 52; thence with the southern side of said drive, S. 67-46 W. 90 feet to the point of beginning;
