ALSO, ALL that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, containing 21.47 acres as is more fully shown on a plat prepared by John C. Smith, R.L.S., July 19, 1967, representing a tract of land owned by John D. Huff to be deeded to S. Ed Mayfield and having, according to said plat, the following metes and bounds, to-wit:
