"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Highland Township, about seven miles north of Greer, located on the northeastern side of the Jordan Road, containing 1 acre, more or less, as shown on survey for K. V. Sloan, dated August 18, 1970, by W. N. Willis, Engineer, said survey to be recorded herewith, and having, according to said survey, the following metes and bounds, to-wit:

BEGINNING at a nail in the center of the Jordan Road (iron pin back at 33 feet), and running thence N. 51-30 B. 210 feet to an iron pin; thence S. 38-30 B. 210 feet to an iron pin; thence S. 51-30 W. 210 feet to a nail in center of Jordan Road (iron pin back at 33 feet); thence along and with the Jordan Road, N. 38-30 W. 210 feet to the point of beginning.
