NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, about 7 miles Southwest of the City of Greenville, and being known and designated as Lot Number 42 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book OOO at Page 193, and having the following metes and bounds, to wit:

BEGINNING at a point on the Western side of Driftwood Drive at the joint front corner of Lots 41 and 42 and running thence with the Western side of Driftwood Drive S 2-38 W 24.4 feet to a point; thence continuing with the Western side of Driftwood Drive S 6-41 E 113.2 feet to a point; thence still continuing with the Western side of Driftwood Drive S 25-08 E 113 feet to a point at the joint front corner of Lots 42 and 43; thence S 55-36 W 286 feet to a point at the joint rear corner of Lots 42 and 43; thence N 46-32 W 394 feet to a point at the joint rear corner of Lots 41 and 42; thence N 75-08 E 460.6 feet to a point on the Western side of Driftwood Drive at the point of BEGINNING.
