

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Richbourg Drive being known and designated as Lot No. 20 of Wade Hampton Terrace Subdivision, plat of which is recorded in the R.M.C. Office in Greenville County in Plat Book WK at Page 15 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the eastern side of Richbourg Drive, joint front corner of Lots 19 and 20 and running thence N.57-28 E. 164.8 feet to an iron pin; thence S.44-0 E. 32.8 feet to an iron pin; thence S.15-16 E. 100.05 feet to an iron pin; thence with the common line of Lot 20 and 21 S.71-49 W. 153.7 feet to an iron pin to the eastern side of Richbourg Drive; thence with said Drive N.28-05 W. 90 feet to the point of beginning.
