First: The provisions contained in this Article IV shall be null and void upon assignment of this mortgage and security agreement to C. Douglas Wilson & Co. or Metropolitan Life Insurance Company, but until such assignment shall be filed for record in the Office of the Clerk of Court or the Office of the Register of Memo Conveyance in the County wherein the premises are situate, the provisions of this Article IV shall be in full force and effect and shall prevail over other provisions contained in this mortgage and security agreement in the event of a default.
