"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwestern corner of the intersection of Donington Drive and Aberdare Court, and being shown and designated as Lot 124 on a plat of Kingsgate by Piedmont Engineers and Architects, recorded in the RMC Office for Greenville County in Plat Book WWW, Pages 44 and 45, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point on the west side of Aberdare Court, joint corner of Lots 123 and 124, and running thence along the common line of said Lots S. 58-19 W. 102.9 feet to a point, joint rear corner of Lots 124 and 125; thence along the common line of said Lots N. 29-53 W. 155.25 feet to a point on the south side of Donington Drive; thence along Donington Drive N. 58-19 E. 112.0 feet to a point at the curve of the intersection of Donington Drive and Aberdare Court; thence following the curve of said intersection, the chord of which is S. 69-38 E. 30.8 feet, to a point on the west side of Aberdare Court; thence along said Aberdare Court S. 17-35 E. 135.0 feet to the point of beginning.
