"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, containing one acre, more or less, according to a plat prepared by W. J. Riddle, Surveyor, and having the following metes and bounds, to wit:

BEGINNING at a point in the center of Old White Horse Road at the corner of property of Peden and Quinn, formerly S. H. Granger, and running thence along the line of said Peden and Quinn property, N. 34-30 E. 490 feet to an iron pin; thence N. 55-30 W. 91 feet to an iron pin; thence S. 34-42 W. 451 feet to a point in the center of the Old White Horse Road; thence along said Road, S. 33-E. to the point of beginning.
