All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 20 of a subdivision known as Pine Knoll Forest as shown on plat prepared by Carolina Engineering and Surveying Co., November 26, 1962, and recorded in the R.M.C. Office for Greenville County in Plat Book XX at Page 187 and having the following metes and bounds, to-wit:
