All that piece, parcel or lot of land in Greenville County, State of South Carolina, shown on plat entitled, "Survey for G & M Rentals, Inc.," by Carolina Engineering and Surveying Company dated November 25, 1970 and having, according to said plat, the following metes and bounds:
