Credit Company, (hereinafter "Mortgagor") in the above Total of Payments and all future advances from Mortgagor to Mortgagor, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagor, its successors and assigns, the following described real estate together with all improvements thereon situated in South Carolina, County of **GREENVILLE**, ALL THAT LOT OF LAND IN THE COUNTY OF GREENVILLE, STATE OF SOUTH CAROLINA, BEING KNOWN AND DESIGNATED AS LOTS NOS. 31 & 32 ON REVISED PLAT OF COLEMAN HEIGHTS RECORDED IN THE RMC OFFICE FOR GREENVILLE COUNTY IN PLAT BOOK DDD AT PAGE 197 AND HAVING ACCORDING TO SAID PLAT THE FOLLOWING METES AND BOUNDS COURSES AND DISTANCES, TO-WRITE: BEGINNING AT AN IRON PIN ON THE EAST SIDE OF WEST DRIVE; THENCE WITH THE CURVE OF SAID STREET AS IT INTERSECTS WITH MILL CREEK ROAD, THE CHORD OF WHICH IS N. 30-44 E. 35.7 FEET TO AN IRON PIN ON THE SOUTH SIDE OF MILL CREEK ROAD; THENCE WITH THE SOUTH SIDE OF SAID ROAD N. 75-07 E. 145.2 FEET TO AN IRON PIN; THENCE S. 7-18 E. 90.8 FEET TO AN IRON PIN; THENCE CONTINUING S. 7-08 E. 122-2 FEET TO AN IRON PIN ON THE NORTH SIDE OF A 50 FT. UNNAMED ROAD; THENCE WITH THE NORTH SIDE OF SAID ROAD S. 70-53 W. 137.1 FEET TO AN IRON PIN; THENCE WITH THE CURVE OF SAID ROAD AS IT INTERSECTS WITH WEST DRIVE, THE CHORD OF WHICH IS N. 57-26 W. 31 FEET TO AN IRON PIN ON THE EAST SIDE OF WEST DRIVE; THENCE WITH THE EAST BIDE OF SAID STREET N. 5-45 W. 100 FEET TO AN IRON PIN; THENCE CONTINUING WITH THE WEST SIDE OF SAID STREET N. 13-38 W. 75 FEET TO THE BEGINNING CORNER.
