"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that piece, parcel and lot of land in Butler Township, Greenville County, State of South Carolina, being 2.3 Acres fronting on State Road No. 580, as shown on a Plat of property of Willie and Bernice Henderson, dated April 24, 1971 by C. F. Webb, R. L. S., the same recorded concurrently with this deed and made a part thereof, and being more particularly described as follows:

BEGINNING at an old iron on State Road and property of Gambrell and running thence along State Road N. 30-56 W. 233 feet to I. P. to Creek is the Line as shown on the Plat; thence Creek is the Line (Travis Line) N. 37-43 E. 469.7 feet to Iron Pin (Creek is the Line); thence S. 30-56 E. 215 feet to old iron pin; thence S. 35-42 W. 476.6 feet to the point of beginning.
