NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgages at any time for advances made to or for his account by the Mortgages, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly peld by the Mortgages at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at Mauldin, S. C., known as Lot No. 9 on Plat of Leake & Garrett, made by Jones and Sutherland, February 27, 1958, and having, according to a plat entitled "Kendall T. Bailey" recorded in the R.M.C. Office for Greenville County in Plat Book ZZ, Page 139, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Woodland Drive at the corner of Lot No. 10, which iron pin is situate 193.5 feet southwest of the intersection of Whatley Circle, and running thence N. 54-54 W. 172.8 feet to an iron pin; thence S. 35-11 W. 90 feet to an iron pin; thence S. 54-54 E. 172.9 feet to an iron pin on the northwestern side of said Drive: thence along said Drive N. 35-06 E. 90 feet to thepoint of beginning.

This being the same property as conveyed to Grantor Mortgagors by deed recorded in the R.M.C. Office for Greenville County in Deed Book 908, at Page 333.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its-heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
